

## **\*\*ALP Music App Privacy Policy\*\***

### **\*\*General\*\***

ALP Music, L.L.C. (“ALP”) designed, built, developed, and owns the ALP Music Mobile App (the “ALP Music App”). The ALP Music App provides a service for ALP customers, and is intended for use as-is and as-available.

However, the ALP Music App also involves the utilization of third-party services, and your use of the ALP Music App may require the collection of information used to identify you (“Personal Information”).

This page serves as notice to you regarding the collection, use, and disclosure of Personal Information. By using the ALP Music App, you agree to the collection and use of such Personal Information as may be required and to be bound by this ALP Music App Privacy Policy (the “Privacy Policy”).

### **\*\*Information Collection and Use\*\***

For a better experience, ALP may require users of the ALP Music App to provide, or ALP may collect, certain Personal Information, including but not limited to a valid Email Address, dates of purchased licenses for musical works by way of the ALP Music App, and, in some instances, Log Data (described below). The information ALP requests will be retained by ALP and used as described in this Privacy Policy. ALP will not use or share your information with anyone except as described in this Privacy Policy unless required to do so by law.

However, the App also involves the utilization of third-party services, including without limitation, service providers relating to mobile download of the ALP Music App (e.g. Apple, Google Play, etc.), mobile payment platforms for collecting and processing purchases (e.g. credit card vendors), and/or other third-party providers of services (collectively, the “Third-Party Services”). Generally, the ALP Music App requires utilization of the Third-Party Services to:

- \* To facilitate the service provided by the ALP Music App;
- \* To perform services related to the ALP Music App or use of the ALP Music App; or
- \* To assist us in analyzing how the ALP Music App is used or can be improved.

Through their policies, procedures, or requirements, these Third-Party Services have access to your Personal Information. ### **\*\*Log Data\*\***

In the event of an error in the ALP Music App, ALP collects data and information (through Third-Party Services) on your phone called Log Data. This Log Data may include information such as your device's Internet Protocol (IP) address, device name, operating system version, the configuration of the ALP Music App when utilizing it, the time and date of your use of the ALP Music App, and other statistics.

### **\*\*Cookies\*\***

Cookies are files with a small amount of data that are commonly used as anonymous unique identifiers. These are sent to your browser from the websites that you visit and are stored on your device's internal memory.

The ALP Music App does not use these cookies explicitly. However, the ALP Music App may utilize Third-Party Services using code and/or libraries that use cookies to collect information. You have the option to either accept or refuse these cookies and know when a cookie is being sent to your device. If you choose to refuse the cookies, you may not be able to use some portions of the ALP Music App.
